The legal basis of the processing referred to in point d. is the legal obligation the Data Controller is to comply with.

### NATURE OF DATA PROVISION

Except for the purpose referred to in the aforementioned point c., the provision of personal data collected for the above purposes is necessary for the proper organization and management of the Event.

#### PROCESSING METHODS

Data will be processed and collected through paper-based instruments, computer and telematic media, suitable for ensuring the security and confidentiality of the data, in accordance with the provisions of art. 32) of the European Privacy Regulation UE/2016/679 (GDPR) and art. 31) of Legislative Decree 196/03 on "appropriate security measures" and art. 33) of Legislative Decree 196/03 on "minimum security measures".

However, by carrying out the processing operations the minimum level of data protection required by law is guaranteed by adopting all the technical, computer, organizational, logistical and procedural security measures, as provided for in Annex B of Legislative Decree no. 196/03. Your Data will be likewise processed only by personnel expressly authorized by the Data Controller.

It is also common ground that this authorization is granted free of charge and that nothing will therefore be due to you for any such use and/or disclosure of the images and/or videos where you appear.

The purpose referred to in point c. of the paragraph "purpose of the processing" of this Privacy Notice is based on the creation, preservation and updating of a historical archive containing materials relating to Teoresi Group, its history and its activities in general. Personal Data may be processed, in Italy and/or abroad, in any printed and/or audiovisual form, as well as by any disclosure means.

### DATA RECIPIENTS
